### **RESPONDING WELL TO SURVIVORS - UPDATE**

The Diocesan Safeguarding Advisory Panel (DSAP) met in April and focussed on how we are listening to, engaging with, supporting and learning from those with lived experience of abuse.

DSAP reviewed the recently launched Responding Well to Victims and Survivors of Abuse guidance document, which can be found in the e-manual.

There is a lot of ongoing work around listening to survivors, and this will continue to be a priority at both a national and local level. Some examples include:-

- At a national level +Philip chairs the project board that is tasked with setting up the National Redress Scheme.
- In addition to our work with First Light we are working in partnership with Men Against Sexual Abuse (MASA) to deliver a bespoke and funded service for male victims of church based abuse.



- Updating our 'I am concerned what can I do' information on our website, to include developing a flowchart that shows what support is available and how to access it.
- Working with the Senior Leadership

Team to review the 'issuing of apologies by Church Bodies' section.

We are continuing to work our way through the guidance. Watch this space for some exciting developments in the autumn.

### MEN AGAINST SEXUAL ABUSE **FUNDED COUNSELLING**

Men Against Sexual Abuse (MASA) is a registered charity that was set up to support males from the age of 16 upwards who have experienced sexual abuse during their lifetime.

#### SAFE SPACES: FREE INDEPENDENT SUPPORT SERVICE

Safe Spaces is a free and independent support service, providing a confidential, personal and safe space for anyone who has been abused by someone in the Church or as a result of their relationship with the Church of England, the Catholic Church in England and Wales or the Church in Wales.

Although the churches have funded the service, it is run independently by the charity Victim Support, who are one of the leading charities providing specialist support to survivors of abuse in England and Wales.

If you have been affected, however long ago, Safe Spaces can provide you with support. You do not have to have told the police or the church authorities, and you do not have to still be involved with the church. Your information will not be shared without your consent unless you or someone else is in immediate danger.

You can contact the Safe Spaces team by phone, live chat or by filling in a self-contact-referral form. Further information can be found on their website.

#### RAISING AWARENESS OF DOMESTIC ABUSE

Domestic abuse awareness month takes place in October with the aim of raising awareness of the various types of domestic abuse and the various forms it comes in.

The Church of England is working nationally to plan events, workshops and interactive sessions so that we can all actively participate. We will pass on any information in our next briefing note.

We would like to remind you of the online training that was launched in November 2021. Anyone who holds the Bishop's licence, commission, authorisation or permission, Parish Safeguarding Officers, Ordinands and PCC Members are required to undertake this training during 2022. To date 40 people across the



PCC's, diocese and cathedral have undertaken this module.

# SPIRITUAL ABUSE: WHAT IS IT ALL ABOUT?


Spiritual Abuse is not a separate category of abuse but is a form of psychological and emotional abuse within a religious context.

The Safeguarding Children, Young People and Vulnerable Adults guidance, which can be found in the safeguarding e-manual notes that in relation to spiritual abuse, Church Officers must:

- i) Listen carefully, avoid interrupting and allow a full disclosure without feeling they must defend the Church or the individual.
- ii) Respond in a non-judgemental manner, demonstrating that the disclosure of spiritual abuse is being taken seriously.
- iii) Avoid minimising what they are being told or showing disbelief or denial.
- iv) Be aware that victims may have experienced harmful teaching.
- v) Avoid suggesting the use of Matthew 18 (resolving disputes by speaking directly to the person). It is harmful to suggest that someone speaks to their abuser about their abuse.
- vi) Be aware that a disclosure of spiritual abuse may also be part of a disclosure of other forms of abuse.
- vii) Where abuse has involved use of scripture or prayer, think carefully and be judicious about whether it is appropriate to use this as a first response to a disclosure.

# SAFER RECRUITMENT & PEOPLE MANAGEMENT: SHARING BEST PRACTICE

It has been six months since the introduction of the SRPM guidance, which we know you are working hard to implement.

For those PCCs which are using the Parish Dashboards, 27 have identified that they are fully compliant with SRPM and 74 are actively working towards compliance.

We will be looking to hold some more drop in sessions over the next few months if they would be helpful.

As a reminder if you are involved in recruitment you must do SRPM online training.

Currently 85 Clergy/parish officers, 21 diocesan staff and 3 cathedral staff have completed the training.

Not only is it a requirement for those of us involved in recruitment it is a good way to understand the guidance.

Access to the training requires logging into the **CofE online portal**.

# SURVIVOR ENGAGEMENT SURVEY LAUNCHED

A national anonymous survey to understand how victims and survivors would like to be involved in the development and implementation of a Church of England survivor engagement framework has been launched.

The purpose of the survey is to listen to victims and survivors about how they would like to be involved in developing and implementing the framework and enable victims and survivors of any form of abuse to engage in different workstreams within the Church, including its response to victims and survivors of abuse.


The survey is open for any victim or survivor, including children and young people, and all responses will be anonymous. It takes approximately 13-15 minutes to complete.

The survey will run until September 18, 2022, and the learning from the survey will inform a publicly accessible report, which will include key themes and next steps to develop the framework.

The report will be published online in Church's survivor engagement webpage which has also just launched.
