DOMESTIC VIOLENCE & ABUSE AWARENESS

Domestic abuse is "any incident or pattern of incidents of controlling, coercive or threatening behaviour, violence or abuse between those aged 16 or over who are or have been intimate partners or family members regardless of gender or sexuality.

Domestic abuse is such a major form of abuse across society – including within the Church. Figures from diocesan safeguarding audits show that in 2019 and 2020 domestic abuse and sexual abuse were the forms of abuse with the highest numbers of reported concerns / allegations in respect of adults. 20% of all safeguarding concerns / allegations about adults concerned domestic abuse in 2020 (19% for sexual abuse).

How can I find out more?

PCC members can offer real leadership in respect of domestic abuse – and victims of domestic abuse need champions. House of Bishops Guidance on "Roles and Responsibilities" states that the PCC "has the responsibility, along with the incumbent to promote the mission of God in its parish." It goes on to say "The PCC and the incumbent have a duty of care to ensure the protection of the vulnerable in their church community. In terms of safeguarding, with the incumbent the PCC will promote a safer church for all in the church community, and ensure there is a plan in place to raise awareness of, promote training and ensure that safeguarding is taken seriously by all

those in the church community."

Domestic abuse awareness training is available via the **online training portal**.

How are we raising awareness?

Domestic Violence awareness month takes place internationally in October, the aim is to raise awareness of the various types of domestic abuse and the various forms it comes in.

The Church of England will be raising awareness of domestic through 16 days of sound bites and videos starting in November, followed up by training in 2023. Watch this space for more information about how you can get involved.

PCC TRAINING - WHAT ARE THE REQUIREMENTS?

The safeguarding training requirements for PCC members are contained in the **Church's Safeguarding Learning and Development Framework**, which was approved by the National Safeguarding Steering Group in April 2021. The Framework is formal House of Bishops Safeguarding Guidance.

In terms of commitment, the requirements of PCC members is that

they complete Basic and Foundation Safeguarding training within six months of starting in role. After that they need to complete the domestic abuse module within the next 30 months. This works out to an average of 1.5 safeguarding training per annum.

DIOCESAN SAFEGUARDING ADVISORY PANEL

The Diocesan Safeguarding Advisory Panel (DSAP), which meets quarterly, advises the diocesan bishop (Bishop Philip) of how: safeguarding is working across the diocese, we are engaging with survivors and working with our partners.

Each meeting focusses on one of our four key themes: being survivor led, strengthening our leadership culture and increasing capacity & supporting our parishes. The panel includes external partners, a Survivor Advocate and parish representatives.

Hearing directly from parishes about their safeguarding experiences is one of the key areas of the DSAP work. We understand that not everyone has the time or feels able to be a member of DSAP and therefore Justine Hosking, our Independent Chair has been considering how we can better engage with you.

We are proposing to provide regular updates, via this briefing note, about DSAP discussions. In addition to the parish representatives on DSAP, we will be setting up some drop in sessions with Justine in the new year. MODERN SLAVERY MODULE ON E-PORTAL

Modern slavery is present in every single community. According to the Global Slavery Index, there are 136,000 victims in the UK and most of these people go unnoticed, hidden in plain sight. The methodology used by criminal gangs to control victims is increasingly sophisticated and always evolving. For this reason, it is essential that safeguarding officers keep their knowledge up to date.

OCTOBER 18 IS ANTI-SLAVERY DAY

To help galvanise our communities to act against modern slavery, The Clewer Initiative is launching a new campaign - Make it Slavery Free. The hope is that groups and individuals will work towards building slavery-free communities by pledging to carry out three anti-slavery actions this year. This could include setting up a social action project, England's response to modern slavery, has recently revised the Modern Slavery module on the Church of England's online safeguarding portal. The new, interactive material shares insight about how modern slavery is manifesting itself within UK communities and how to recognise, respond, refer and record concerns.
